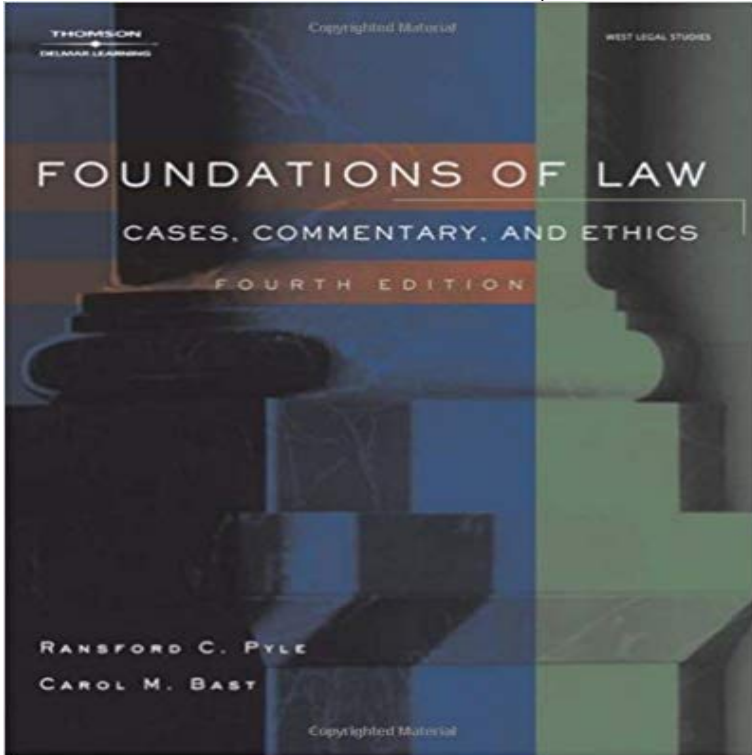


# Foundations of Law: Cases, Commentary and Ethics
