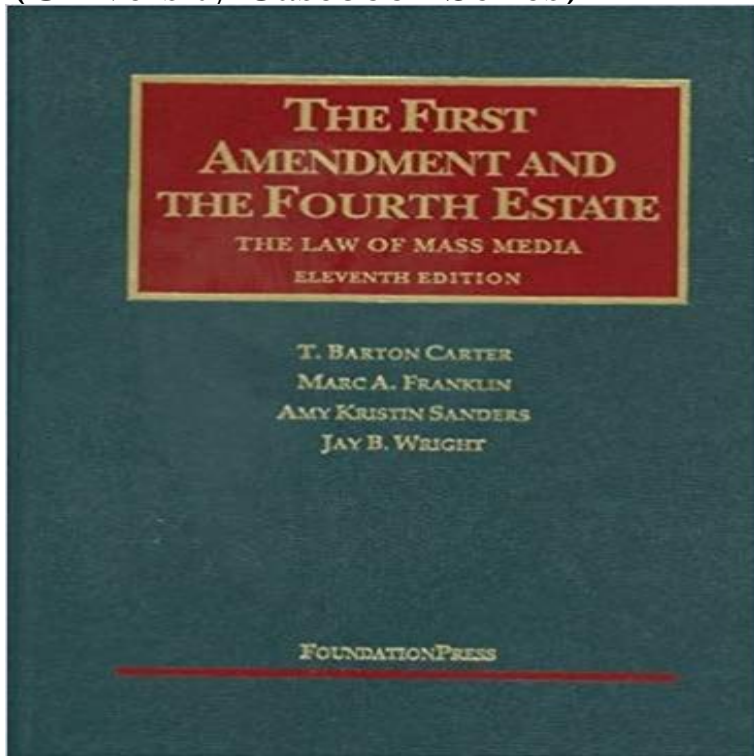


The First Amendment and the Fourth Estate: The Law of Mass Media (University Casebook Series)
