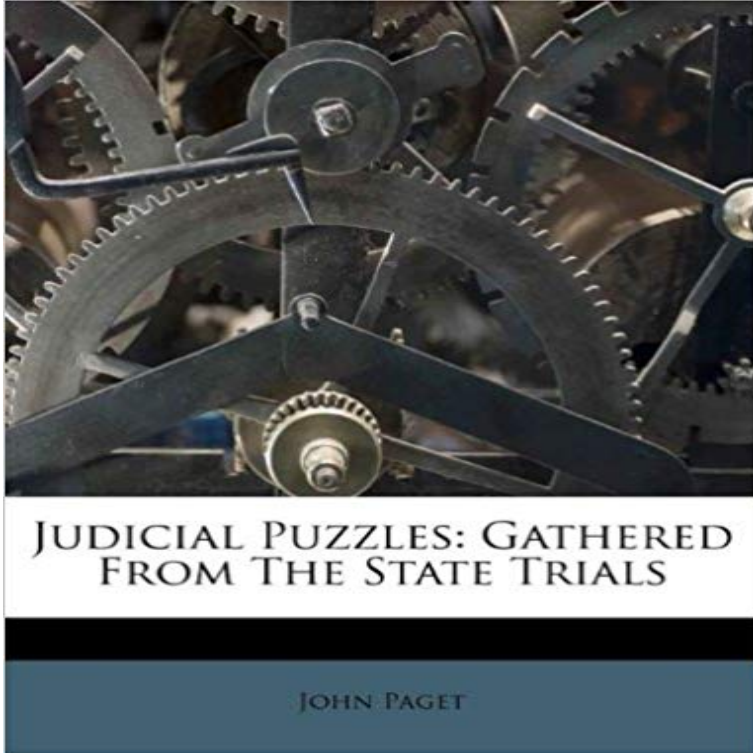


# Judicial Puzzles: Gathered From The State Trials
