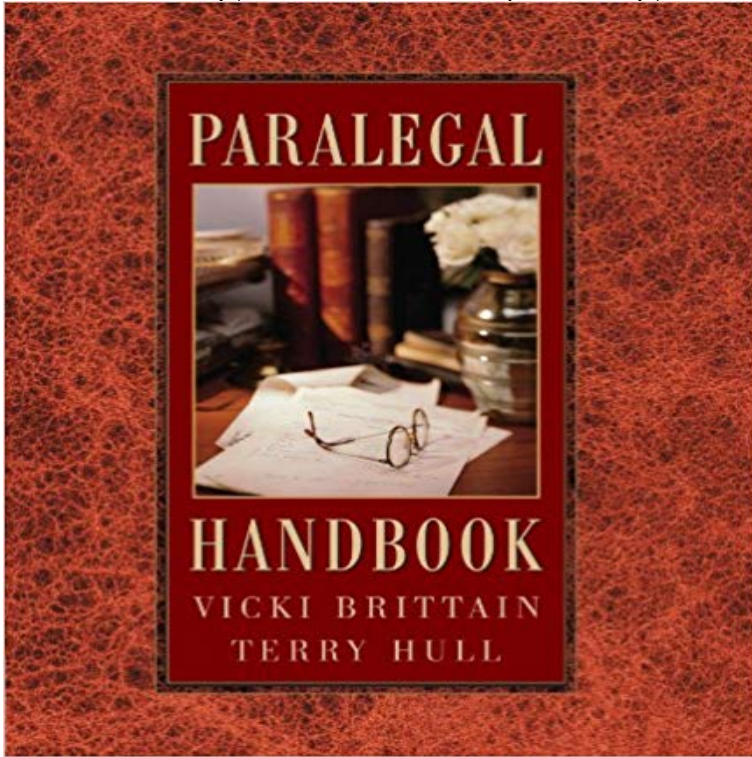


The Paralegal Handbook (Paralegal Reference Materials)
