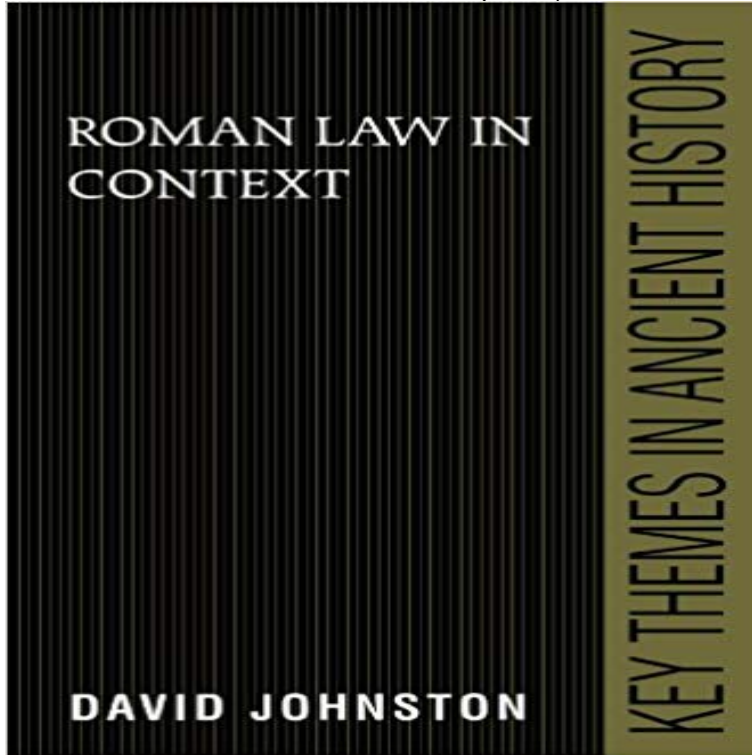


Roman Law in Context (Key Themes in Ancient History)
