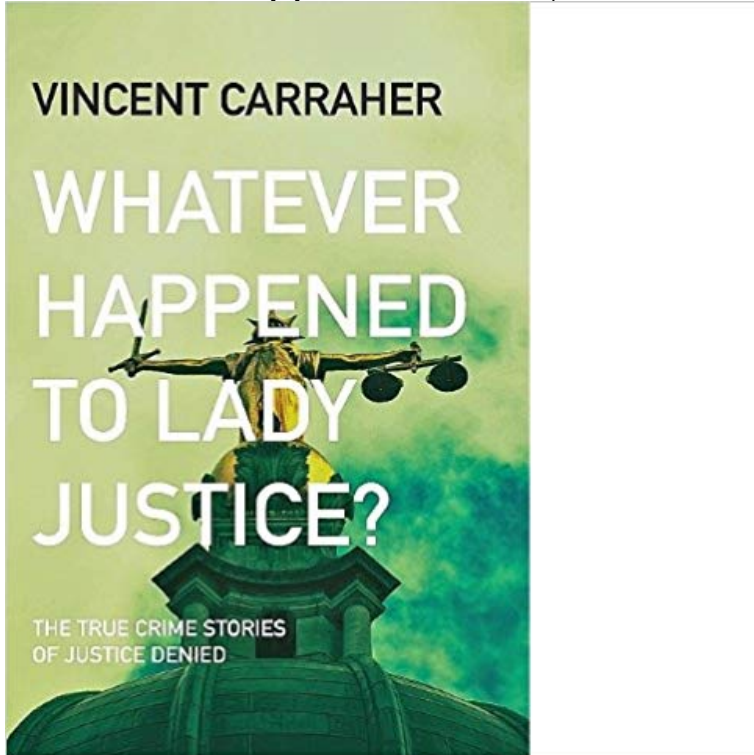


Whatever Happened to Lady Justice
