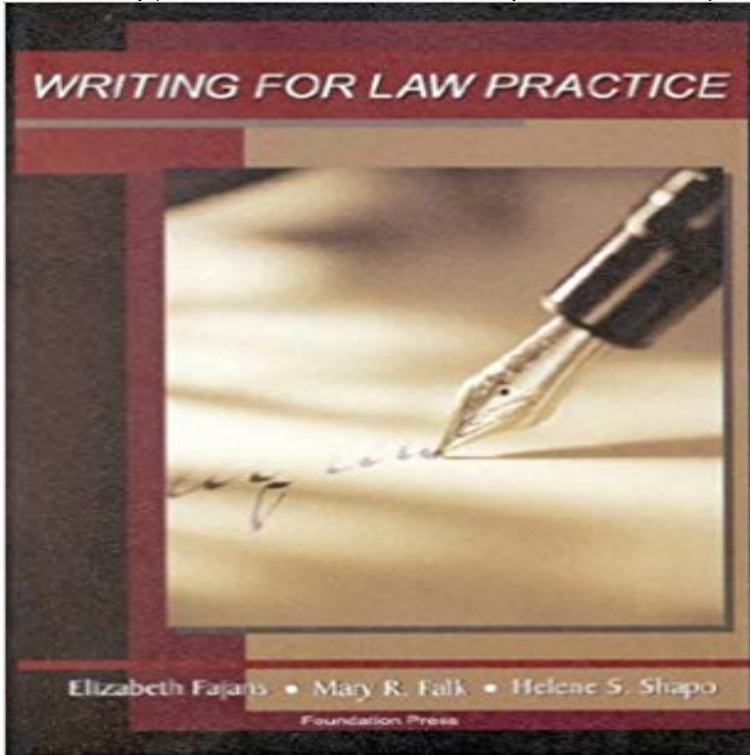


Writing for Law Practice (University Casebooks)
